

Population Served and Scope of Services

- ✓ Medicaid/Peachcare Insurance carriers or Sliding-Fee-Scale/ No Insurance
- ✓ Promote family stabilization and reunification for youth five to seventeen (5-17) years of age.
- ✓ Services are provided for an initial period of 90 days with a thorough comprehensive assessment.
- ✓ Clients have access to licensed therapists, mental health professionals, and paraprofessionals. If needed the client has access to psychiatrists and/or psychologists and nurses.
- ✓ Services take place in the privacy of the home or in a setting beneficial to improving the client's functioning.
- ✓ Program offers 24 hours a day, 7 days a week crisis support.
- ✓ Clients are referred by parents or other family members, school counselors, probation officers, Department of Family and Child Services (DFCS), Department of Juvenile Justice (DJJ), community agencies, or other environmental resources in which the child may be involved.
- ✓ Provide service to Clayton, DeKalb, Douglas, Fayette, Fulton, Henry, and the Atlanta Metro area.

Program Emphasis

House of Inspiration's (HOI) provides two types community-based service programs—Intensive Family Intervention (IFI) and Community-Based Alternatives for Youth (CBAY). Both programs provide home-based crisis intervention plans used to prevent out-of-home placement (youth detention center, therapeutic foster care, residential treatment facility, psychiatric hospital, etc.) for children and youth in families experiencing crisis.

The IFI and CBAY services are primarily available to youth who have serious emotional disorders or substance abuse disorders. Caseloads are kept low to allow for an intense level of interaction between staff, youth, and family. These programs are authorized by Georgia Department of Human Resources. IFI services are covered by Georgia Medicaid/Peachcare and CBAY services are covered by grant funding (The CBAY grant does provide coverage for children who are enrolled in a CMO.).

HOI's Team Works to:

- Diffuse the current behavioral health crisis
- Evaluate the crisis' nature and provide interventions in order to reduce the recurrence
- Provide linkage to appropriate community resources
- Promote self-resilience in the individual child/adolescent's ability to self-recognize and self-manage behavioral health issues
- Assists the parents/caregivers capacity to care for their children

HOI Provides the Following Services:

- In-Home Individual and Family Counseling
- Substance Abuse Counseling
- Communication /Life Skills Training
- Parenting Education
- Community Resource Linkage
- Behavior Modification
- Anger Management
- Respite and Transportation (CBAY only)/24-hour Residential Care (DFCS only)

Philosophy and Objectives

HOI's **philosophy** is to enhance the quality of life for youth by promoting unity, strengthening relationships, and assisting in development of positive emotional health.

HOI's program model is **family focused** and allows family members to work as full partners. This allows the family team to increase their ability to provide for the complex mental health needs of the at-risk child and to identify and use strengths in the home, school, and community to ensure the child's safety and well-being. The focus is also placed on the social, emotional, physical, and educational needs of the child. Additionally, HOI's program is **solution focused** to provide the families with tailor made interventions and strategies that promote child and family stability.
